General Terms and Conditions of enrollment and participation to:

Important: these Terms and Conditions regulate the enrollment request and the possible following acceptance & participation in the “Cars & Coffee” Event. Enrollment entails overall submission to these conditions, which the Participant undertakes by clicking “submit.” In case of missing agreement to the Terms and Conditions, it will not be possible to fulfil the enrolment procedure.

1 General Information:

Cars & Coffee (“the Event”) is NOT a race or competition. It is compulsory to drive safely and to abide by the traffic laws with respect to other Participants and to the Event audience. [Name of the Organiser] (“the Organization” and/or “the Organizer”) reserves the right to exclude those who display inappropriate behaviors from further Events.

2 Enrollment Fee:

The enrollment fee for a vehicle and its Driver (“the Participant”), covering whole day of Event is [...] VAT included. This fee includes the following:

3 Age:

The Participant is required to be in possession of a valid driving license and to have reached the age of majority to attend the Event as a Driver. Age restriction and others do not apply to extra guests.

4 Legal Compliance :

The Participant is required to abide by the traffic laws, including those regarding speed limits, road safety and driving under the effects of alcohol, drugs and other prohibited substances. The Participant hereby declares to be in possession of a valid driving license and to be in the proper psychophysical conditions to drive their vehicle, hence relieving the Organization of any related responsibility. Should one of these rules be infringed, the Organization reserves the right to exclude the Participant from further Events.

Participation in the Event is strictly bound to the vehicle indicated at enrollment. The Organization reserves the right to reject the Participant who reports for the Event with an unregistered vehicle. By registering to the Event, Participants commit to attend the Event. Should they be unable to attend the Event, the Enrollment fee can be transferred exclusively upon approval of the Organization.

5 Advertising:

Participants are prohibited from displaying any form of advertising on their vehicles, unless authorized by the Organization. The Organization will be inspecting vehicles at their arrival and for the duration of the Event, and shall have any unauthorized form of advertising removed. Those infringing the abovementioned conditions will be excluded from any future Event. The Organization reserves the right to charge transgressors of these conditions



with possible damages deriving from the infringement thereof. Participants hereby undertake to reimburse the Organization and/or third parties for every and each possible damage consequent to the infringement of these regulations, hence relieving the Organization of any related responsibility.

6 Official Program:

The definition “Official Program” implies that the information provided in the program may be subject to variations (with regards to Event venues, road directions, menu and any other items in the program).

7 Admitted vehicles:

The number of vehicles admitted to the Event is strictly limited to [...] cars. Vehicles shall be selected by the Organization among the total of enrollment requests. In order to guarantee the highest profile and widest variety of exhibited vehicles, the Organization reserves the right to admit vehicles at its incontestable discretion.

8 Admission to Cars & Coffee and possible complaints:

The Organization reserves the right to autonomously select the vehicles to be admitted in the Event. It is not possible to file complaints or appeal to such decision.

9 Objection to Fees:

The financial commitments required by the organization of the Event contribute in the definition of the enrollment fee (e.g. production costs, marketing and communication costs, implementation costs etc.). No objection concerning enrollment fees will be therefore admitted upon Event completion. Enrollment fees are given for accepted upon enrollment on the basis of Event typology, offered services and quality thereof.

10 Renunciation:

In case of full or partial withdrawal from the Event, the Participant is required to notify [Organiser Name] via registered mail at the legal address of the company ([...]). In case of withdrawal,

- 50% of the enrollment fee will be refunded if renunciation is notified by (hour) of (date).
- The enrollment fee shall NOT be refunded if renunciation is notified after (hour) of (date).
- When due, the refund will be forwarded within [...] days from notification.

Should Participants fail to notify their renunciation, they will have no right to reimbursement. In case of withdrawal from the Event consequently to road accidents and mechanical defiance involving other Participants' vehicles and/or third-party vehicles, Participants will have no right to reimbursement. Variations in the composition of the crew (“the Participant and Extra Guests”) must be authorized by the Organization.

11 Reasons of force majeure:

The Organization has no obligation to fulfill the expected services in case reasons of force majeure prevent so. Reasons of force majeure include strikes, adverse weather conditions, war, civil or military disorders, riots, natural catastrophes, looting and terrorist attacks. Similar occurrences are not imputable to the Organization. Should such circumstances verify, no reimbursement, refund or indemnity shall be due to the Participant and/or crew on behalf of the Organization.

The Event will still take place in case of rain or bad weather.

12 - Logo and Trademark:

Intellectual Property and Copyright: The Participant cannot claim any right on the “CARS & COFFEE” verbal and figurative trademarks. The Participant and their crew hereby undertake not to claim property, license or any other right of use and abuse of the trademarks. The Participant and their crew further commit not to file or use names, marks or other distinctive signs in combination with the “Cars & Coffee” registered name and trademarks, nor to use other signs that may be liable to be confounded with the “Cars & Coffee” trademarks.

The website www.cars.coffee and its contents (including but not limited to information, graphic items, photo, audio/video material, and texts) are protected by copyright and are owned by Cars & Coffee srl, unless otherwise stated. The services and contents of the website are protected by the Italian copyright law and by the International copyright law. Reproductions and/or imitations of the website contents are strictly forbidden.



13 Imitations and replicas of the Event:

The Participant undertakes not to organize Events that replicate the characteristics and prerogatives of the Cars & Coffee Event. The possible violation of this commitment will be legally persecuted by the Organization to safeguard its rights and interests.

14 Image rights, waiver and indemnity:

With the submission to these Terms and Conditions, Cars & Coffee srl and/or entrusted entities are authorized to take pictures and audio-video recordings of the Participants, of their crew, of their vehicles, of goods, and of logos of property, within the general context of the Event. Each Participant freely and indefinitely yields and transfers onto the Organization the rights of use of the photo, and audio-video material recorded by Cars & Coffee or those by Cars & coffee entrusted. The Organization is authorized to indefinitely keep the photo, and audio-video material, to trade it, yield it to third parts and to use it in any way the Organization may consider appropriate and to spread them and edit them at its own discretion in the form of editorial productions (including, but not limited to, newspapers, books, magazines, social networks, websites etc.) and/or by any mean, way and system (including, but not limited to, cable, satellite and digital Television, radio, internet – downloading, streaming, analogical and/or digital systems) currently known and/or possibly invented in the future with no limits of space, duration and transfer, and by total or partial divestiture to third parties. Each Participant releases Cars & Coffee from liability of third-party claims on the above mentioned photo, audio and video material.

15 Civil Responsibility and Indemnity:

Each Participant declares to have taken out an insurance policy on their vehicle as per current insurance regulations. The Participant hereby releases Cars & Coffee and its affiliated operators from any liability concerning possible damages to the Participant and/or their crew and/or goods. The Participant also relieves the Organization and its affiliated operators of any responsibility concerning damages to third parts and/or goods caused by the Participant and/or their Crew. The Organization and its operators cannot be held responsible on behalf of the Participant for bad maneuvering and consequent damaging of vehicles while driving or parking. The Participant further relieves Cars & Coffee from any responsibility whatsoever in case of theft and /or fire and/or vandalism and/or other damages the vehicle may be subject to during the Event. The Participant shall furthermore refrain from claiming any reimbursement for possible damages both for themselves and for their heirs. At any moment of the Event, vehicles are NOT under the custody of Cars & Coffee and/or its operators.

16 Applicable Legislation and Place of Jurisdiction:

These General Terms and Conditions are regulated and understood in accordance with the Italian law.
